## **Your WSCC**

### Who We Are

Workers' compensation is insurance for workers and employers. Employers pay assessments into a common fund and the Workers' Safety and Compensation Commission (WSCC) pays benefits to injured workers or their dependants using this fund. Workers' compensation is the law and no industries are exempt.

We administer the Workers' Compensation Acts, the Safety Acts, the Mine Health and Safety Acts, the Explosives Use Acts, and associated Regulations to protect workers in the Northwest Territories and Nunavut. The WSCC strongly promotes incident and injury prevention to improve Northern safety cultures through education and support, and ensures workers injured on the job receive the appropriate care and compensation.

Employers in the Northwest Territories and Nunavut cover our administrative costs, the cost of compensation to injured workers or their dependants, as well as payment of pensions, medical aid, and rehabilitation.

A seven-person Governance Council, representing the interests of workers, employers, and the public sector, governs the WSCC. The Northwest Territories and Nunavut Ministers responsible appoint the Governance Council.



### What We Do

In addition to improving Northern safety cultures through education and support, our main business is insurance and compensation for injured workers. We have a number of divisions, providing internal and external services, to ensure we address the needs of employers and workers. External services include Industrial and Mine Safety, Claims and Medical Services, and Employer Services.
